DIRECTIONS:

From the North: 1-75 South to Rt 4 North (right exit) Take Findley Sreet Exit (right turn). Go east to First Street. Make a left on First Street. First Street dead ends onto Springfield St. Left on Springfield St. for 1+ miles. Building is on the right.

From the South: 1-75 North to First Street then to Springfield St. Follow above directions. Located in the rear of the building beyond the fence – Look for the large dog cut outs on the building
